OMB INCLUDES NEW "FORESIGHT" DEFINITION IN CIRCULAR A-11:

In July 2020, the White House released an update to OMB Circular No. A-11 which provides guidance on preparing the FY 2022 Budget and Budget Execution. For the first time, OMB included a definition of "Foresight" in [Part 6 Section 200.22](#). The definition explains incorporating foresight into strategic planning, to help agencies prepare for multiple possible futures. (POC: [OMB](#))

STATE OF FORESIGHT AMONG THE FORTUNE 500:

Last fall the Houston Foresight program led an effort to explore the "state of foresight." The effort explored the basic question "who is actually doing foresight?" The study revealed that only 25% of US Fortune 500 companies practiced foresight in some form. While this is the first time the study has been conducted, there is much to learn from this impressively low figure. Future studies hope to identify the number of corporations, government agencies, etc. that practice foresight and the maturity level of the practice. (POC: [Andy Hines](#))
